ORDER : The Court made the following order :-

This petition has been filed to relax the condition imposed on the petitioners in Crl.O.P.(MD).No. 15068 of 2025 dt. 11.09.2025.

2. The learned counsel for the petitioners submitted that the petitioners have been complying with the conditions regularly imposed by this Court and he prays for relaxation of the said condition.

3. The learned Government Advocate (Crl. Side) submitted that the petitioners have been complying with the conditions regularly and A5 has 13 previous cases.
