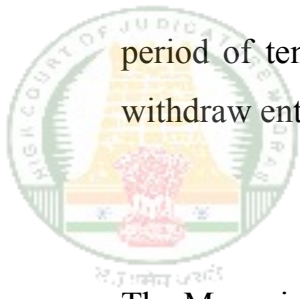

This case came up for settlement before the Lok Adalat. Both the parties present. The counsel for the appellant/s Mr.S.Micheal Heldon Kumar and the first respondent - Ms.Anto Arul Rathinam - Party-in-person are present. After mutual discussion, negotiation, mediation and conciliation between both parties and with the assistance of the Bench, both sides consented for settlement.

AWARD

After discussion and negotiation, the appellant / Transport Corporation and respondents / claimants agreed for a sum of Rs.1,40,000/- (Rupees One Lakh Forty Five only) as full quit. The appellant / Transport Corporation has already deposited a sum of Rs.25,000/-(Rupees Twenty Five Thousand only).

2. The appellant/Transport Corporation is directed to deposit the balance amount of Rs. 1,15,000/-(Rupees One Lakh Fifteen Thousand only)[Rs1,40,000/- (-) Rs.25,000/-] within a



period of ten weeks from today. On such deposit, the first respondent / claimant is to withdraw entire award amount, less the amount already withdrawn, if any.
