ORDER

This writ petition has been filed for a Writ of Mandamus directing the respondents to settle interest at the rate of 6 percent per annum for the belated payment of petitioners terminal benefits including Provident Fund, Gratuity, Terminal Leave Salary and Commuted Value of Pension from the date of the petitioners retirement i.e. from 31.08.2023 to 25.08.2025, the date on which the said benefits were settled to him.

2. Considering the admitted fact that there has been a delay in payment, the petitioner is entitled to statutory interest as provided under law.
