### **ORDER**

He submits that the first respondent would pass orders on merits within three (3) months from the date of receipt of a copy of this order after providing a reasonable opportunity to the petitioner and the fourth respondent.

3. In view of the above submissions of learned Special Government Pleader, it is not necessary to issue notice to the fourth
