3.We direct the third respondent to conduct survey of S.No.201/1.

Notices will be issued to all the interested persons. If the survey exercise reveals that there is encroachment, individual notices will be issued to all the encroachers and by adhering to due process of law, the encroachments shall be removed. The entire exercise shall be completed within a period of three months from the date of receipt of a copy of this order.

4.The writ petition is disposed of accordingly. No costs.
