2.Today(16.12.2025), when this writ petition is taken up for hearing, the learned Additional Government Pleader submits that the Accountant General/first respondent herein has raised certain queries and therefore, the eligible pension benefits of this petitioner have been revised and it has been resubmitted to the Accountant General.
