PRAYER :- To enlarge the petitioner on bail in C.C.No.537 of 2025 on the file of learned Judicial Magistrate No.I Padmanabhapuram.

ORDER : The Court made the following order :-

The petitioner, who was arrested and remanded to judicial custody on 20.09.2025 for the offences punishable under Sections 303(2) of BNS, in Crime No.325 of 2025 on the file of the respondent police, seeks bail.

2. The case of the prosecution is that the petitioner took away a sum of Rs.2,00,000/- from the defacto complainant's bag. Hence, the complaint.

3. The learned counsel for the petitioner submitted that the petitioner is an innocent person and he has not committed any offences as alleged by the prosecution. He further submitted that the petitioner is in judicial custody from 20.09.2025. Hence, he seeks bail to the petitioner.

4. The learned Additional Public Prosecutor submitted that two previous cases are pending against the petitioner. He further submitted

that the charge sheet has been filed.

5. Taking into consideration the fact that the charge sheet has been filed and also considering the period of incarceration suffered by the petitioner, this Court is inclined to grant bail to the petitioner, subject to the following conditions:

6. Accordingly, the petitioner is ordered to be released on bail on executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties, each for a like sum to the satisfaction of the learned Judicial Magistrate No.1, Padmanabhapuram, and on further conditions that :-

[a] the petitioner and the sureties shall affix their photographs and left thumb impression in the surety bond and the Magistrate may obtain a copy of their Aadhaar card or bank pass book to ensure their identity.

[b] the petitioner shall report before the trial Court on all hearing dates without fail.

[c] the petitioner shall not tamper with the evidence
