2. The present Writ Petition has been filed for a writ of Mandamus to direct the respondents to settle the petitioner's retirement benefits including gratuity, commutation of pension, arrears of monthly pension from 31.07.2022 till the date of realization of amount as per the settlement dated 24.08.2022 under section 12(3) of ID Act 1947 w.e.f. 01.09.2019, payable to him with 18 % rate of interest.

3. The learned counsel for the petitioner submits that the issue raised in this writ petition is covered by an earlier order passed by this Court and has placed reliance on the order made in W.P(MD)No.20522 of 2025 dated 29.07.2025.
