4. The learned counsel for the petitioner would submit that it would suffice if the representation of the petitioner dated 09.06.2025 is considered by the respondents on its own merits and in accordance with law.

Considering the limited scope of the prayer sought for in this writ petition, without expressing any opinion on the merits of the matter, the respondents are directed to consider the petitioner's representation dated 09.06.2025 and pass final orders on its own merits, within a period of one month from the date of receipt of a copy of this order, after affording reasonable opportunity to the petitioner.

7. Accordingly, this Writ Petition is disposed of. No costs.
