He submits that a revision petition has been filed by Alagarsamy and Venkatesan against the petitioner for cancellation of the patta in respect of survey Nos.120/12 and 120/13. Until the said revision petition is disposed of, he submits that it is not possible to consider the request for survey.

3. In view of this development, this Writ Petition is disposed of by leaving it open to the petitioner to reapply for a survey depending on the
