ORDER

2. Heard the learned counsel for the petitioner, the learned Additional Government Pleader appearing for the respondents 1 and 2 and the learned Government Advocate for the respondents 3 and 4.

3. The petitioner submitted an online application for conducting field survey and measurement of the petitioner's property at S.No.75/3B,

Needless to say that if any rival claims, the same shall be subject to the jurisdiction of the civil court. There shall be no order as to costs. Consequently connected Miscellaneous Petition is closed.
