ORDER

However, the learned counsel would submit that the petitioner is a lady; and that her appearance before the Trial Court may be dispensed with.

3. In view of the above submission, this Criminal Original Petition is dismissed as withdrawn. The personal appearance of the petitioner before the Trial Court is dispensed with on all hearing dates (provided she is represented by a lawyer) unless her appearance is required by the learned Magistrate for the progress of the trial. Consequently, connected Miscellaneous Petitions are closed.
