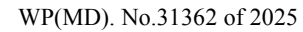

In view of the same, this writ petition is disposed of with a direction to the respondents to settle the difference of pay, as per the settlement arrived under Section 12(3) of the Industrial Disputes Act, to the petitioner, within a period of eight weeks from the date of receipt of a copy of this order.
