Judge, Thoothukudi, which was filed for the offences under Section 25(1B)(b), 30 and 35 of Arms Act, 1959.

2. During the course of arguments, when this Court expressed that the points raised by the learned counsel for the petitioner are factual in nature, the learned counsel for the petitioner sought permission to withdraw this petition. However, the learned counsel would submit that the petitioner is undergoing treatment for diabetes and low blood pressure and that his appearance before the Trial Court may be dispensed with.

3. In view of the above submission, this Criminal Original Petition is dismissed as withdrawn. The personal appearance of the petitioner before the Trial Court is dispensed with on all hearing dates (provided he is represented by a lawyer) unless his appearance is required by the learned Judge for the progress of the trial. Consequently, connected Crl.M.P.(MD).No.17492 of 2025 is closed.
