The learned counsel appearing for the petitioner would submit that the petitioner is aged about 86 years and is bedridden and he has produced the medical certificate stating that he is a known case of coronary artery disease/post PCI-angioplasty status/Hypertension and he was advised to take medicine and to avoid exertion and travel.
