2. Considering the admitted fact that there has been a delay in payment, the petitioner is entitled to statutory interest as provided under law.

The respondents are directed to pay interest at the rate of 6% per annum on the belated terminal benefits payable to the petitioner from the date of his entitlement till the date of his payment within a period of 12 weeks from the date of receipt of a copy of this order.
