The petitioner, who apprehends arrest at the hands of the respondent police for the offences punishable under Sections 8(c) r/w 20(b)(ii)(B) of NDPS Act, in C.C.No.1022 of 2022 on the file of the Communal Clash Cases in Southern District Madurai, in Crime No.104 of 2022 on the file of the respondent police, seeks anticipatory bail.

2.The learned counsel appearing for the petitioner submitted that due to ill health, the petitioner was unable to appear before the trial Court, hence, the trial Court has issued an NBW against the petitioner. He further submitted that the petitioner is ready and willing to abide by any stringent conditions that may be imposed by this Court. Hence, he seeks to grant anticipatory bail to the petitioner.

3.The learned Additional Public Prosecutor appearing for the respondent submitted that the offences committed by the petitioner are serious in nature.

4. Considering the facts and circumstances of the case, this Court is directing the petitioner to surrender and submit a recall petition before the 1st Additional Special Court (NDPS) Act, Madurai. Upon such a petition being

filed, the 1st Additional Special Judge (NDPS), Madurai, shall consider the petition in accordance with the law on its merits on the same date.

5.With the above said directions, the Criminal Original Petition is disposed of.
