PRAYER: Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus to direct the second respondent to consider her representation dated 01.08.2024 and 10.02.2025, and direct the third respondent to consider her representation dated 03.03.2025, cancel the entry regarding survey

numbers 84/5 and 84/6, in Pathinettankudi village, Mellur taluk, Madurai District, measuring 0-7.00 and 0-5.00 hectare in Revenue records as Boomithan land issue patta for the above land in name of K.Kaliammal or her legal heirs.

ORDER

By relying on a sale deed dated 19.08.1969 in favour of the petitioner's mother and the legal heir certificate relating to the petitioner's mother, the petitioner had made multiple representations to cancel the entry regarding survey Nos.84/5 and 84/6 in the revenue records describing the lands as 'Bhoomithan land' and to issue patta to the petitioner. The present Writ Petition relates thereto.

2. Learned Special Government Pleader accepts notice for all the respondents. He points out that the Revenue Divisional Officer has issued a communication to the District Collector regarding the petitioner's request and advertng to the classification of the land as 'Bhoomithan land' in the revenue records. He also submits that a final

decision has to be taken by the Commissioner of Land Administration.
