The petitioner claims that this is a public interest litigation. The prayer is to break the 150 meter road median on Theni-Periyakulam main road such that there would be direct access to the Government Vetarinary Hospital, Government Fair Price Shop and HP Petro Bunk of Theni Allinagaram.

2. The petitioner has infact made a representation on 11.09.2025 seeking the same relief and hence, it would suffice that the authorities be directed to consider the same.
