ORDER

2. Considering the admitted fact that there has been a delay in payment, the petitioner is entitled to statutory interest as provided under law.

3. In view of the same, the Writ Petition stands disposed of. The respondents are directed to pay interest at the rate of 6% per annum on the belated terminal benefits payable to the petitioner from the date of his
