ORDER: The Court made the following order :-

The petitioner, who apprehends arrest at the hands of the respondent police for the offences punishable under Sections 457, 397, 120(B), 411, 395 and 75 of IPC, P.R.C.No.13 of 2023 on the file of the Judicial Magistrate Court, Palani, connection with Crime No.187 of 2023 on the file of the respondent police, seeks anticipatory bail.

2.The learned counsel appearing for the petitioner submitted that the petitioner due to his illness, was unable to appear before the trial Court, hence, the trial Court has issued an NBW against the petitioner. He further submitted that the petitioner is ready and willing to abide by any stringent conditions that may be imposed by this Court. Hence, he seeks to grant anticipatory bail to the petitioner.

3.The learned Government Advocate (Crl.Side) appearing for the respondent submitted that the offences committed by the petitioner are serious in nature.
