2. The learned Counsel for the petitioner would contend that the sole plaintiff in the suit died on 09.12.2023 and even as of today no steps have been taken on the side of the plaintiff to bring on record the legal heirs of the deceased plaintiff.

3. Since the sole plaintiff is no more, the suit must necessarily stand abated.
