This writ petition have been filed for a writ of Mandamus to direct the respondents to revise and re-fix the grade pay as Rs.4600/- to Rs.5100/- to the post of Assistant Engineer with effect from 29.02.2016 and pay other all retirement benefits including pension by considering the petitioner's representation dated 30.10.2025 in the light of the proceeding issued by the office of the first respondent vide Ref.No. 232/SECY/TNSTC(VPM)/2023 dated 23.01.2024.

2. Heard the submission of both sides counsel and perused the materials available on record.

No.232/SECY/TNSTC (VPM)/ 2023 dated 23.01.2024 and pass orders on merits and in accordance with law, within a period of eight (8) weeks from the date of receipt of a copy of this order.

5. With the above direction, the Writ Petition stands disposed of.
