Considering the nature of the offence, the condition imposed by the Trial Court in Crl.M.P.No.442 of 2025 dated 19.08.2025, is hereby modified to the effect that the petitioner is ordered to be released on bail on his execution of bond for a sum of Rs.25,000/- (Rupees Twenty Five Thousand only) with two sureties each for a like sum to the satisfaction
