ORDER

The petitioner seeks a direction to the respondents 1 to 3 to grant permission for conducting Minnoli Kabadi competition, scheduled to be conducted from 15.11.2025 to 16.11.2025 in Sevalur Village, Pudukottai Post, Sivakasi Taluk, Virudhunagar District, by considering the petitioner's representation dated 07.11.2025.

2.The learned Additional Public Prosecutor appearing for the respondents would submit that the petitioner's representation was considered and rejected, since the permission cannot be granted for conducting the tournament in the place sought for by the petitioner. He would further submit that the respondents would consider the alternative
