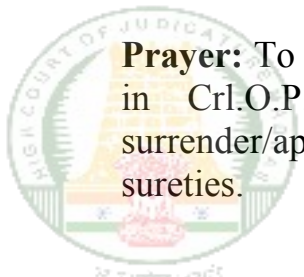

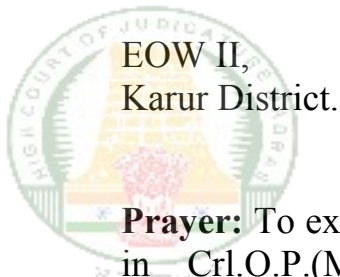

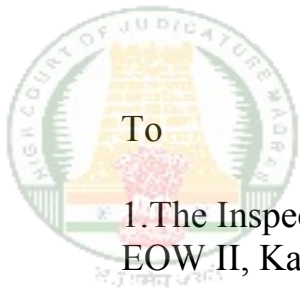
2. Heard the learned counsel for the petitioners and the learned Government Advocate (Criminal Side) appearing for respondent.
