The appeal and the stay application, if filed within the stipulated time limit, shall be entertained by the appellate authority and the stay application shall be decided within four weeks of institution of the appeal, after hearing the petitioners, in line with principles of natural justice and in accordance with law. Hence, for a period of five weeks from today, or till the disposal of stay application once filed, whichever is earlier, status quo shall be maintained.

4. It is made clear that if the aforesaid liberty is not availed by the petitioners within a period of one week from today, the impugned order shall stand restored and the benefit granted to the petitioners under this order shall stand revoked, without further reference to the petitioners. No costs. Connected miscellaneous petitions are closed.
