PRAYER: Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus to direct the respondents to survey the Petitioner's properties and fix boundary stones in respect of Survey No.29/4A2 to an extent of 39 cents situated at Naalumaavadi Village, Eral Taluk, Thoothukudi District, based on the Petitioner's representation dated 04.10.2025 within a time frame to be stipulated by this Court.

ORDER

By relying on a partition deed dated 15.11.2010 and the subsequent settlement deed dated 12.08.2021, the petitioner had applied for a survey of the land in survey No.29/4A2 of the extent of 39 cents. The present Writ Petition relates thereto.

2. Learned Special Government Pleader accepts notice for all the respondents. He submits that action would be taken on the petitioner's request for a survey after issuing notice to the pattadars under patta No. 2419.

3. Learned counsel for the petitioner confirms, on instructions, that there is no rival title claim. He also points out that survey No.29/4A was subdivided after the settlement and that the portion settled in favour of the petitioner is 39 cents in survey No.29/4A2.

4. The petitioner has submitted both title and revenue records relating to the property. It is also stated that there is no rival title claim. In these circumstances, this Writ Petition is disposed of by directing the second and third respondents to initiate action on the petitioner's request for a survey after issuing notice to the pattadars and the owners of relevant adjacent lands. The entire process shall be concluded within three (3) months from the date of receipt of a copy of this order. No costs.
