ORDER

This writ petition has been filed for a Writ of Mandamus directing the respondents to settle the interest at the rate of 6percent per annum for the belated payment of petitioners terminal benefits including Gratuity, Provident Fund, Earn Leave Salary, Surrender Leave Salary and RBSR full amount from the date of the petitioners retirement to till the date on which the said benefits were settled to the petitioner.

2. Considering the admitted fact that there has been a delay in payment, the petitioner is entitled to statutory interest as provided under law.
