ORDER

3. The learned counsel for the petitioner however would state that the second respondent is still interfering in the dispute.

4. The learned Additional Public Prosecutor on instructions would further submit that the respondents 1 to 3 would not interfere in any civil dispute between the petitioner and the private respondents.
