ORDER

2. Heard the learned counsel for the petitioner and the learned Special Government Pleader appearing for the respondents. By consent of both sides, the writ petition itself is taken up for final disposal at the stage of admission itself.

3. The petitioner submitted a representation to the 3rd respondent on 17.10.2025 for issuance of patta for the petitioner's property. However, no action has been taken on the said petition. Hence, the present writ petition has been filed.

4. Learned Special Government Pleader, appearing for the respondents, submits that the petitioner's representation would be
