ORDER

This Habeas Corpus Petition has been filed by the mother of the detenu complaining that her daughter aged about 19 years had been missing from 18.10.2025.

2. The matter was referred to Mediation and Conciliation Centre attached to this Bench and at the Mediation, the parties have entered into settlement agreement on 27.11.2025. The parties, counsel and Mediator have signed the agreement. The detenu Ram Priya married one Maran on 24.10.2025 at Thirupandur Kalamman Temple. The settlement agreement is recorded. In view of the settlement agreement, this Habeas Corpus Petition is disposed of and the settlement agreement shall form part and parcel of the order.
