PRAYER: Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus to direct the first respondent to take necessary steps to Speed up and complete the enquiry proceedings of the file in Na.Ka.157/2025/AA4, dated 13.02.2025 relating to Patta No.2283 and early disposal in accordance with law.

ORDER

The petitioner asserts that he is the owner of the properties described in paragraph No.2 of the affidavit under sale deed dated 07.06.1991 bearing Doc.No.944 of 1991. Learned counsel for the petitioner points out that the revenue records also stand in the name of the petitioner, but that respondents 4 and 5 have applied for the cancellation thereof. She submits that this petition has been filed seeking the early disposal of the cancellation petition.

2. Learned Government Advocate accepts notice for respondents 1 to 3. He submits that the Revenue Divisional Officer would consider and dispose of the appeal on merits within three (3) months after providing a reasonable opportunity to all parties thereto.

Advocate, it is not necessary to issue notice to the private respondents in this Writ Petition.
