By relying on a patta No.83 in the name of the petitioner's mother-in-law, Guruvammal, the petitioner had applied for a survey of the land in survey No.290/26.

2. Learned counsel for the petitioner submits that the petitioner's mother-in-law passed away on 16.07.2021 and that the only surviving Class-I legal heirs are her husband, Muthaiah and her brother-in-law, Elangovan. He also submits that there is no rival title claim and that the brother-in-law lives separately with his family.

3. Learned Additional Government Pleader accepts notice for both the respondents. He submits that a notice would be issued to the legal heirs of the petitioner's mother-in-law, Guruvammal and to owners of relevant adjacent lands before a decision is taken.

4. In these circumstances, this Writ Petition is disposed of by directing the respondents to consider the petitioner's request for a survey after issuing notice to both the legal heirs of the deceased pattadar.

Notice should also be issued to owners of relevant adjacent lands.

Objections, if any, from the above persons shall be taken into consideration before a decision is taken. The entire process shall be concluded within three (3) months from the date of receipt of a copy of this order. No costs.
