4. The order shall be treated as a show cause notice. The petitioner has also submitted his explanation to the alleged demand on 01.03.2025.

The respondents shall consider the said explanation by affording an opportunity of personal hearing to the petitioner and thereafter, pass appropriate orders on merits and in accordance with law. Therefore, the order impugned in so far as it relates to the the 1st respondent is directed to be quashed.

5. Accordingly, the writ petition stands allowed. No costs. Consequently, connected miscellaneous petitions are closed.
