ORDER

2. The present Writ Petition has been filed for a writ of Mandamus to direct the respondents herein to revise the wages of the petitioner with effect from 01.09.2023 based on the 15th wage settlement dated 29.05.2025 and to pay arrears of wages payable from 01.09.2023 to

29.02.2024, difference in Leave Salary and arrears of pension from 01.03.2024 to 31.07.2025 along with interest at the rate of 12% per annum from the date of wage settlement ie., 29.05.2025 till the date of actual payment.

3. The learned counsel for the petitioner submits that the issue raised in this writ petition is covered by an earlier order passed by this Court and has placed reliance on the order made in W.P(MD)No.20522 of 2025 dated 29.07.2025.

4. The learned Standing Counsel for the respondents also does not dispute the said fact.

5. In view of the same, the respondents are directed to release the eligible benefits to the petitioner together with 6% interest from the due date till the date of disbursement, within a period of 12 weeks from the date of receipt of a copy of this order.
