Prayer: Writ Petition filed under Article 226 of the Constitution of India praying this Court to issue a Writ of Mandamus, directing the



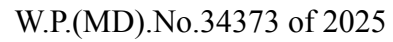

respondents to compute and pay difference amounts in the benefits in respect of Gratuity, Encashment of Leave Salary, Monthly Pension by taking Dearness Allowance at 50% i.e. on par with serving employees of Transport Corporation with Arrears to the petitioner from the date of his retirement ie.31.03.2024 as per, in terms of the 15th wage revision settlement entered under section 12(3) of I.D Act dated 29.05.2025 together with interest at the rate of 6% per annum for the differential payment to be computed from the date of his retirement till the date of payment within a time frame as may be fixed by this Court.
