PRAYER: Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus to direct the first Respondent to direct the third Respondent to survey and fix the boundary marks of the petitioner's lands in Patta No. 1678 in Survey No. 305/2A2B and its extent of 0.2.06 ares of Muthalvarpatty Village, Marungapuri Taluk, Trichy District with the help of the fourth Respondent based on his application dated 06.08.2025 within a period of

ORDER

By relying on a sale deed dated 02.11.2015 and patta No.1678, the petitioner applied online for the survey of 2.06 ares in survey No. 305/2B2A in Muthalvarpatty Village. The present Writ Petition relates thereto.

2. Learned Additional Government Pleader accepts notice for respondents 1 to 3 and learned Government Advocate (Crl.Side) accepts notice for the fourth respondent. Learned Additional Government Pleader submits that notice would be issued to adjacent landowners and their objections would be considered before taking a decision.

3. The petitioner has placed on record a sale deed dated 02.11.2015

and the patta. *Prima facie*, there appears to be a minor discrepancy between the sale deed area of 202.52 square meters and the patta area of 206 square meters. This aspect may be examined by the revenue officials before taking a decision. It is also necessary to issue notice to owners of relevant adjacent lands and consider their objections, if any.

4. Subject to the above observations, this Writ Petition is disposed of by directing the third respondent to initiate action on the petitioner's request for a survey after issuing notice to the persons mentioned in the previous paragraph. The entire process shall be concluded within three (3) months from the date of receipt of a copy of this order. No costs.
