ORDER

This writ petition has been filed for a writ of Mandamus to direct the respondent to pay the petitioner interest at the rate of 18% per annum, for the period of delay from 01.04.2024 to 24.08.2025, in paying the amounts paid towards his terminal benefits namely EPF Employee's Contribution, Gratuity, Encashment of Leaves/Already Surrendered Earned Leaves and VRS Compensation within a time frame as may be fixed by this Court.

2. Considering the admitted fact that there has been a delay in payment, the petitioner is entitled to statutory interest as provided under law.

3. Learned counsel for the petitioner would restrict his claim of interest at the rate of 6% per annum.
