PRAYER :- For Anticipatory Bail in C.C.No.25 of 2013 on the file of the Special Court for TNPID Cases, Madurai, in Crime No.01 of 2010 on the file of the respondent police.

ORDER: The Court made the following order :-

The petitioner, who apprehends arrest at the hands of the respondent police for the offences punishable under Sections 120 B r/w 406, 420 & Section 5 of TNPID Act, 1997, in C.C.No.25 of 2013 on the file of the Special Court for TNPID Cases, Maduri, in Crime No.01 of 2010 on the file of the respondent police, seeks anticipatory bail.

2.The learned counsel appearing for the petitioner submitted that due to ill health, the petitioner was unable to appear before the trial Court, hence, the trial Court has issued an NBW against the petitioner. He further submitted that the petitioner is ready and willing to abide by any stringent conditions that may be imposed by this Court. Hence, he seeks to grant anticipatory bail to the petitioner.

3.The learned Government Advocate (Crl.Side) appearing for the respondent submitted that the offences committed by the petitioner is serious in nature.

4. Considering the facts and circumstances of the case, this Court is directing the petitioner to surrender and submit a recall petition before the

Special Court for TNPID Cases, Madurai. Upon such a petition being filed, the

Special Court for TNPID Cases, Madurai, shall consider the petition in accordance with the law on its merits on the same date.
