ORDER

The petitioner has served as a conductor in the respondent transport corporation and retired from service on 31.05.2013. The petitioner with a grievance that his retirement benefits have not been calculated properly, has submitted a representation to the respondents and filed this writ petition.

2.When this writ petition is taken up for hearing, there is no representation for the petitioner.

3.The learned counsel appearing for the respondents has produced a proceedings dated 06.12.2025 and submits that the petitioner's benefits has been calculated by taking into his date of joining and his date of regularisation and therefore, there is no error in the calculation.
