S-38. Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, to call for the records pertaining to the impugned order passed by the 3rd Respondent vide proceedings in (TNSTC/VNR/ESTT/155/2025, dated 29.10.2025), and quash the same as illegal, and consequently direct the Respondents to re-fix the pay of the Petitioner by adopting the 2.57 multiplier/matrix on par with the 7th Pay Commission revision from the date of promotion and revise all other retirement benefits, including pension, in the light of the order passed in W.P. (MD). No.3609 of 2020 dated 20.06.2023, which was confirmed by the Division Bench in W.A. (MD) No. 1099 of 2024 dated 04.07.2024, within a stipulated time that may be fixed by this Court.
