Sakti Kumar, submitted that the enquiry was conducted by the second respondent and the matter has been amicably settled between the parties, wherein the petitioner himself had agreed to disburse the pending salaries to the third respondent and other workers and a compromise has also been arrived between the parties on 16.10.2025 in C.S.R.No.351/2025.
