ORDER

2. The learned counsel for the petitioner submitted that the petitioner has made a complaint before the 3rd respondent, but till date, no action has been taken.

3. The learned Government Advocate (Crl.Side) Submitted that no such complaint was received, but on a perusal of the typed set of papers, it is seen that the petitioner has given a complaint to the various authorities but not the respondents, Therefore, the present petition cannot be entertained.

4. Considering the above submissions made on either side, this Court directs the petitioner to give a fresh complaint to the respondents 2
