to judicial custody on 04.11.2025 for the offences
punishable under Sections 316(4) of BNS, in Crime No.
225 of 2025 on the file of the respondent police,
seek bail.

The case of the prosecution is that the defacto complainant is one Mr.T.R.Balasundram, Manager of DJ Alagendran Automobiles Pvt., Ltd., and the 1st accused is in-charge of the 1st floor of the company and when checking the stock list, it was found that the 1st accused sold the things and received money through his bank account by returning the product from the customers with the help of the 2nd accused and they did not pay the amount into the account of the company and they swindled the money from the company. The occurrence happened in between the period from 15.11.2022 to 04.08.2025. Thereafter, a case was registered against the accused. Hence, the complaint.

3. The learned counsel for the petitioners submitted that the petitioners are the employees of the company and they are innocent persons and they have not committed any offences as alleged by the prosecution. He further submitted that the petitioners are in judicial custody from 04.11.2025. Hence, he

seeks bail to the petitioners.

4. The learned Additional Public Prosecutor submitted that the petitioners have no previous cases. However, he opposed for grant of bail to the petitioners.

5. Taking into consideration of the facts and circumstances of the case and considering the fact that the petitioners have no previous cases, and considering the nature of offence, and also considering the period of incarceration suffered by the petitioners, this Court is inclined to grant bail to the petitioners, subject to the following conditions:

6. Accordingly, the petitioners are ordered to be released on bail on executing a separate bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) each with two sureties, each for a like sum to the satisfaction of the learned Judicial Magistrate No.II, Trichy, and on further conditions that :-

[a] the petitioners and the sureties shall affix their photographs and left thumb impression in the surety bond and the Magistrate may obtain a copy of their Aadhaar card or bank pass book to ensure their identity;

[b] the petitioners shall deposit a sum of Rs.35,000/- (Rupees Thirty five thousand only) to the credit of the Crime No.225 of 2025. On such deposit, the learned Magistrate shall accept the sureties;

[c] the petitioners shall report before the respondent police daily at 10.30 a.m., until further orders;

[c] the petitioners shall not tamper with the evidence or witness either during investigation or trial;

[d] the petitioners shall not abscond either during investigation or trial;

[e] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate

action against the petitioners in accordance with law as if the conditions have been imposed and the petitioners are released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560];

[f] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 BNS.
