WEB COPY ORDER : The Court made the following order :-

The petitioner, who was arrested and remanded to judicial custody on 15.09.2025 for the offences punishable under Sections 103(1), 126(2), 49, 61(2) (a) of BNS, and corresponding Section 302, 341, 109, 120B of IPC, in Crime No.802 of 2025, on the file of the respondent police, seeks bail.

2. The case of the prosecution is that the defacto complainant is the wife of the deceased Rajkumar. On 12.09.2025 at 08.00 p.m, the deceased while returning home in his two wheeler and coming near the junction of 1<sup>st</sup> and 2<sup>nd</sup> street at Park Town, Madurai, the accused persons armed with knife wrongfully restrained the deceased and assaulted him brutally and caused injuries all over his body due to which, he died on the spot. Hence, the complaint.

3. The learned counsel for the petitioner submitted that the petitioner is an innocent person and he has not committed any offences as alleged by the prosecution. He further submitted that the petitioner is in judicial custody from 15.09.2025. Hence, he seeks bail to the petitioner.

4. The learned Government Advocate (Criminal Side) submitted that the petitioner/A8 is the son of Kallanai/A6, who is the executor of the alleged murder. He further submitted that the petitioner has no previous cases. However, he opposed for grant of bail to the petitioner.

5. The learned counsel appearing for the intervenor vehemently opposed to grant bail to the petitioner since it is a brutal murder.

6. Considering the facts and circumstances of the case, and also considering the fact that accused has executed the alleged murder and eventhough there is no previous case, based on the brutal attack, this

court is not inclined to grant bail to the  
petitioner. Hence, this Criminal Original Petition is  
dismissed.
