PRAYER:- Writ Petition filed under Article 226 of the Constitution of India, to issue a Writ of Certiorari, to call for the records relating to the impugned notice issued by the second respondent in Na.Ka.No. 141/2025/A dated 18.11.2025 and quash the same.



W.P.(MD)Nos.34846 and 34847 of 2025

was allotted to 20 persons, who belong to landless Adi Dravidar community. The petitioners alleged to have purchased the land after acquisition and has no right or title.

3.This Court on verifying the records finding that even if the petitioners have purchased the property for value, they cannot be termed as a *bona fide* purchasers as their vendor has lost title after acquisition of the land and after passing of the award. Therefore, the petitioners have to work out their remedy elsewhere not by way of writ petitions.

4.The writ petitions stand dismissed. No costs. Consequently, connected miscellaneous petitions are closed.
