4. The learned Additional Government Pleader submits that once an application was filed for the four survey numbers, all of them have been surveyed. If at all there is any grievance, the petitioner has to approach the appropriate authorities by filing an appeal or revision as contemplated under Section 12(a) and 12(b) of the Survey and Boundaries Act.

5. In the event of conducting survey for the survey numbers 1180/1 and 1180/3 on an earlier application made, the cause in the writ petition would not survive. It is for the petitioner to approach the competent authority by filing an appeal. However, in the event of the authorities not surveying the above said survey numbers, when an application was made earlier, the same shall be looked into. Needless to say, the exercise shall be completed within a period of twelve weeks from the date of receipt of a copy of this order. With the said observation, the writ petition stands disposed of. There shall be no order as to costs.
