This writ petition has been filed for a direction to the 1<sup>st</sup> respondent herein to conduct enquiry and dispose of the appeal dated 21.07.2025 filed by the petitioner in Na.Ka.No.6353/2025/A1 proceedings based on the subsequent representation dated 10.11.2025 submitted by the petitioner, in accordance with the provisions of the Tamil Nadu Patta Passbook Act, 1983 within a reasonable time frame stipulated by this Court.

2. Heard the learned counsel for the petitioner and the learned Government Advocate for the respondents. By consent of both sides, the writ petition itself is taken up for final disposal at the stage of admission itself.

3. The petitioner has submitted an appeal before the 1<sup>st</sup> respondent for cancelling the mutation of patta in S.No.715. The 1<sup>st</sup> respondent directed the 2<sup>nd</sup> respondent to conduct enquiry and file a report. However, since no action was taken, the petitioner is before this Court with this petition.
