ORDER

The present Writ Petition has been filed seeking a Mandamus as against the first respondent for re-issuance of passport based upon his application dated 07.07.2025.

2. The learned Government Advocate (Criminal Side) appearing for the second respondent brought to the notice of this Court that the petitioner has been implicated in a criminal case in Crime No.664 of 2021 on the file of the second respondent, which has culminated in filing of a charge sheet before the learned Judicial Magistrate, Iluppur, Pudukkottai District on 09.12.2025. However, so far charge sheet has not yet been taken on file.

3. In view of the above said submissions, the petitioner is directed to approach the trial Court concerned seeking permission of the Court to go abroad. In case, if any such application is filed, the same shall be disposed of within a period of four weeks. Based upon the order passed by the Judicial Magistrate, the first respondent is directed to proceed in accordance with law.
